- Royalty Trust Booklets In order for Trust Interest Holders of Royalty Trusts to properly report tax consequences of ownership of a trust interest, certain information is needed. Historically, this information has been distributed by Royalty Trust through annual tax packages or booklets to all Trust Interest Holders. Under the (2009 WHFIT) Widely Held Fixed Investment Trust regulations, this information must now be provided by the Nominees, such as Stifel. The Nominees are permitted, under the new regulation, to provide investors with the address of a web site where the information can be found in lieu of mailing the information. All of this information can be found under Important Disclosures and then Tax Reporting.
