WHAT TO KNOW:

U.S. Equities Fell Last Week

The S&P 500 fell 2% last week despite a strong Friday rebound. No clear catalyst emerged, but concerns over artificial intelligence (AI)-related spending and elevated valuations linger. Third quarter (Q3) earnings are almost over, and Nvidia and Walmart results offered continued support to the AI buildout and consumer resiliency narratives, respectively. Yet, data center construction in the U.S. is part of a much larger structural reindustrialization cycle that will shape U.S. investment, employment, and infrastructure in the decades ahead, which the latest [SightLines](#) discusses.

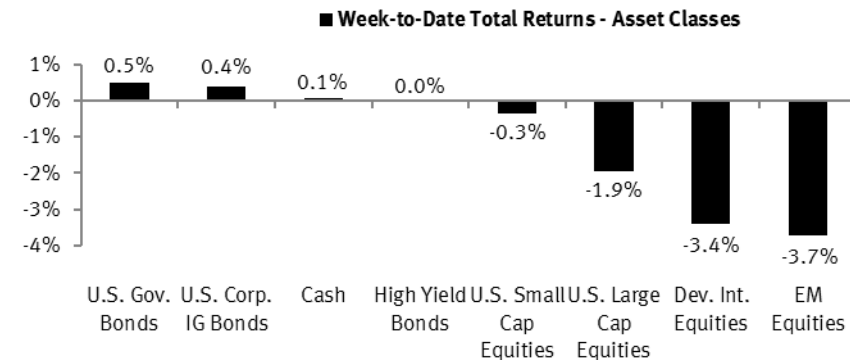
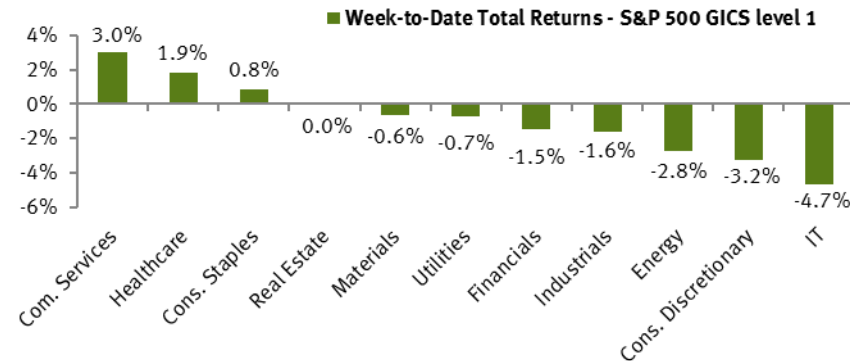
Markets Now Pricing in a December Rate Cut

Markets are pricing in a 70% chance of a 25-basis-point rate cut in December, up from 44% the previous week. The Federal Open Market Committee minutes showed participants were divided on future cuts and two-sided risks. They noted downside risks to employment had increased as job gains slowed, while upside inflation risks persisted, with concerns that inflation could remain even after tariff effects fade. Meanwhile, the New York Federal Reserve President said the Fed can further lower its policy rate as labor market risks outweigh inflation risks, shifting rate cut expectations. A delayed labor report showed the economy added 119,000 jobs in September while unemployment rose slightly to 4.4%.

S&P 500 Is Seeing Its Fastest Revenue Growth in Three Years

Nvidia, the last of the "Magnificent Seven" (M7),** delivered a strong beat-and-raise to their earnings/guidance on explosive data center growth and accelerating pipeline visibility. Walmart also had a solid Q3, underscoring consumer resilience, despite Home Depot and Lowe's seeing a cautious consumer who is deferring big-ticket items and projects. Overall, fundamentals for the S&P 500 are robust as the blended earnings growth stands at 13.4% for Q3 and revenue growth of 8.4%, which is the highest in three years, according to FactSet. Looking ahead, S&P 500 and M7 earnings are expected to grow 7.5% and 19.8% in the fourth quarter, respectively.

NASDAQ Composite Index – The NASDAQ Composite Index is a capitalization-weighted index that is comprised of all stocks listed on the National Association of Securities Dealers Automated Quotation System stock market, which includes both domestic and foreign companies.

S&P 500 Index is a capitalization-weighted index of 500 stocks. The index is designed to measure performance of the broad domestic economy through changes in the aggregate market value of 500 stocks representing all major industries.

S&P 500 Equal Weight Index is the equal-weight version of the widely regarded Standard & Poor's 500 Index, which is generally considered representative of the U.S. large capitalization market. The index has the same constituents as the capitalization-weighted S&P 500, but each company in the index is allocated a fixed weight of 0.20% at each quarterly rebalancing.

S&P GICS Index is a benchmark for investment in the commodity markets and as a measure of commodity performance over time. The index was originally developed by Goldman Sachs. In 2007, ownership transferred to Standard & Poor's, which currently owns and publishes it. Futures of the S&P GSCI use a multiple of 250. The S&P GSCI contains as many commodities as possible, with rules excluding certain commodities to maintain liquidity and investability in the underlying futures markets. The index currently comprises 24 commodities from all commodity sectors.

S&P Consumer Discretionary Select Index includes all companies in the S&P 500 Index classified under the GICS® Consumer Discretionary sector.

S&P Information Technology Index includes all companies in the S&P 500 Index classified under the GICS® Information Technology sector.

MSCI EAFE Index captures large and mid cap representation across Developed Markets countries around the world, excluding the U.S. and Canada. With 914 constituents, the index covers approximately 85% of the free float-adjusted market capitalization in each country.

MSCI Europe Index captures large and mid cap representation across 15 Developed Markets (DM) countries in Europe.

MSCI Emerging Markets (EM) Index captures large and mid cap representation across 23 Emerging Markets (EM) countries. With 837 constituents, the index covers approximately 85% of the free float-adjusted market capitalization in each country.

VIX is a trademarked ticker symbol for the Chicago Board Options Exchange Market Volatility Index and shows the market's expectation of 30-day volatility. It is constructed using the implied volatilities of a wide range of S&P 500 index options. This volatility is meant to be forward looking, is calculated from both calls and puts, and is a widely used measure of market risk, often referred to as the "investor fear gauge."

ISM Non-Manufacturing Index is an index based on surveys of more than 400 non-manufacturing firms' purchasing and supply executives, within 60 sectors across the nation, by the Institute of Supply Management (ISM).

NFIB Small Business Optimism Index is compiled from a survey that is conducted each month by the National Federation of Independent Business (NFIB) of its members. The index is a composite of ten seasonally adjusted components based on questions on the following: plans to increase employment, plans to make capital outlays, plans to increase inventories, expect economy to improve, expect real sales higher, current inventory, current job openings, expected credit conditions, now a good time to expand, and earnings trend.
