STIFEL DECLARES QUARTERLY COMMON STOCK CASH DIVIDEND AND DECLARES PREFERRED STOCK CASH DIVIDEND

ST. LOUIS, November 9, 2022 – Stifel Financial Corp. (NYSE: SF) today announced that its Board of Directors has declared a cash dividend on shares of its common stock of \$0.30 per share, payable December 15, 2022, to shareholders of record at the close of business on December 1, 2022.

The Board of Directors also declared a quarterly cash dividend on the outstanding shares of its 6.25% Non-Cumulative Perpetual Preferred Stock, Series B (the “Series B Preferred Stock”), 6.125% Non-Cumulative Perpetual Preferred Stock, Series C (the “Series C Preferred Stock”), and 4.50% Non-Cumulative Perpetual Preferred Stock, Series D (the “Series D Preferred Stock”). The declared cash dividend on the Series B Preferred Stock, Series C Preferred Stock, and Series D Preferred Stock is for the period from September 15, 2022, up to, but excluding, December 15, 2022. The declared cash dividend equated to approximately \$0.390625 per depositary share, or \$390.625 per share of the Series B Preferred Stock outstanding. The declared cash dividend equated to approximately \$0.3828125 per depositary share, or \$382.8125 per share of the Series C Preferred Stock outstanding. The declared cash dividend equated to approximately \$0.281250 per depositary share, or \$281.250 per share of the Series D Preferred Stock outstanding. The cash dividends are payable on December 15, 2022 to shareholders of record on December 1, 2022.

The Company’s Series B Preferred Stock trades on the New York Stock Exchange under the symbol “SF PrB”, the Company’s Series C Preferred Stock trades on the New York Stock Exchange under the symbol “SF PrC”, and the Company’s Series D Preferred Stock trades on the New York Stock Exchange under the symbol “SF PrD.”
