# MONTHLY MARKET PERSPECTIVES

### **U.S. ECONOMY**

- Third quarter GDP (advance estimate) grew at a 4.9% annualized rate, a bit above consensus. The consumer contributed to more than half of the rise.
- The unemployment rate was unchanged at 3.8% in September from the prior month.
- Consumer sentiment fell to 63.0 in September, largely as a result of concerns about "recent weakness in equity markets."
- Inflation, measured by the consumer price index (CPI), rose 0.4% in September, up 3.7% year over year, driven by an increase in shelter prices.

## **U.S. EQUITY MARKETS**

- Equity markets fell as the <u>Israel-Hamas war</u> weighed on sentiment and investors continue to wrestle with the prospect of higher for longer interest rates. We believe that increased debt and higher rates mean we're headed to a *Fiscal Transition*. Third quarter earnings results so far have been better than expected, with 282 companies having reported through the end of October, and a blended earnings growth rate of 2.96% expected for the quarter. The communication services sector has the largest blended earnings growth rate (41%) while the largest detractor is the energy sector (-38%), a continuation from the second quarter.
- The Russell 1000 Value Index underperformed the Russell 1000 Growth Index (-3.53% versus. -1.42%) in October. Large cap stocks, as represented by the Russell 1000 Index, outperformed small cap stocks, as represented by the Russell 2000 Index (-2.42% versus. -6.82%). The utilities and information technology sectors performed best, up 1.29% and down 0.02% respectively, while the energy sector fell 5.97%.

## INTERNATIONAL ECONOMY AND MARKETS

- The MSCI EAFE Index, representing non-U.S. developed markets, fell 4.05%, as the economic outlook for the eurozone deteriorated. The eurozone composite purchasing managers' index (PMI) fell 0.7 points to 46.5 in October. A reading below 50 indicates a contraction.
- Emerging markets, represented by the MSCI Emerging Markets Index, fell 3.89%, driven by a 4.34% decrease in the MSCI China Index.

# November 2023

#### FIXED INCOME

- Treasury yields climbed to levels last seen prior to the Great Recession. The yield on the 10-year U.S. Treasury rose 36 basis points (bps) to end the month at 4.93%. The 2-10 spread (the difference between the 10-year Treasury yield and two-year Treasury yield) narrowed its inversion to -16 bps from -48 bps in September.
- The Federal Open Market Committee minutes for September showed all participants agreed to maintain the target range at 5.25%-5.50%, taking into consideration the significant cumulative tightening and the lags of previous policy action, while acknowledging monetary policy should remain sufficiently restrictive for some time. Federal Reserve Chair Jerome Powell reiterated this later in the month, noting longer-term bond yields are adding to tightening pressures. While "ongoing progress" to its dual mandate continues, he stressed the Fed will proceed carefully, remaining data dependent, as a lack of progress on labor market loosening and a reversal in the decline of inflation could warrant further tightening.
- At the end of the month, traders of fed funds futures were pricing in a 29% probability that the Fed will raise the benchmark rate another 25 bps before year end.
- Both investment-grade corporate and high-yield spreads widened during the month. The Bloomberg U.S. Aggregate Index fell 1.58%, and the Bloomberg U.S. Corporate High Yield Index fell 1.16%.

#### CURRENCY/COMMODITIES/REAL ESTATE

- West Texas Intermediate (WTI) fell 10.76% to \$81.02/barrel in October from \$90.79/barrel in September.
- Gold prices rose in October, closing at \$1,983.88/oz., up 7.32% from \$1,848.63/oz. in September, as investors headed to perceived safe haven assets.
- The U.S. dollar rose in October against a basket of currencies, closing the month at 106.66 versus 106.17 in September.
- Domestic real estate finished the month lower, as the Wilshire U.S. Real Estate Securities Index fell 4.56% in October.

#### **Index Descriptions**

The Russell 3000 Index measures the performance of the 3,000 largest U.S. companies based on total market capitalization, which represents approximately 98% of the investable U.S. equity market. The average market capitalization is approximately \$4 billion, and the median market capitalization is approximately \$700 million.

The Standard & Poor's 500 Index is a capitalization-weighted index that is generally considered representative of the U.S. large capitalization market.

The Standard & Poor's/TSX Composite Index is the benchmark Canadian index, representing roughly 70% of the total market capitalization on the Toronto Stock Exchange with about 250 companies included in it.

The NASDAQ Composite Index is a capitalization-weighted index that is comprised of all stocks listed on the National Association of Securities Dealers Automated Quotation System stock market, which includes both domestic and foreign companies.

The Russell 1000 Index measures the performance of the 1,000 largest companies in the Russell 3000 Index, which measures the performance of the 3,000 largest U.S. companies based on total market capitalization. The average market capitalization is approximately \$11 billion, and the median market capitalization is approximately \$3.5 billion.

The Russell 1000 Growth Index measures the performance of those Russell 1000 index companies with higher price-to-book ratios and higher forecasted growth values.

The Russell 1000 Value Index measures the performance of those Russell 1000 index companies with lower price-to-book ratios and lower forecasted growth values.

The Russell 2000 Index measures the performance of the 2,000 smallest companies in the broader Russell 3000 Index, which measures the performance of the 3,000 largest U.S. companies based on total market capitalization. The Russell 2000 Growth Index measures the performance of those Russell 2000 index companies with higher price-to-book ratios and higher forecasted growth values.

The Russell Microcap Index is a capitalization-weighted index of 2,000 small cap and micro cap stocks, including the smallest 1,000 companies in the Russell 2000 plus 1,000 smaller U.S. based listed stocks. Over-the-counter stocks and pink sheet securities are excluded.

The MSCI World ex USA All Cap Index captures large, mid, small, and micro cap representation across 22 of 23 Developed Markets (D.M.) countries (excluding the United States). The Bloomberg U.S. Treasury U.S. TIPS index includes all publicly issued, U.S. Treasury inflation-protected securities that have at least one year remaining to maturity, are rated investment grade, and have \$250 million or more of outstanding face value.

The Bloomberg U.S. Municipal Index covers the U.S. dollar-denominated, long-term, tax-exempt bond market. The index has four main sectors: state and local general obligation bonds, revenue bonds, insured bonds, and prerefunded bonds.

The Bloomberg U.S. Credit Index measures the investment-grade, U.S. dollar-denominated, fixed-rate, taxable corporate and government-related bond markets. The Bloomberg Emerging Markets Hard Currency Aggregate Index is a flagship hard currency Emerging Markets debt benchmark that includes U.S. dollar-denominated debt from sovereign, quasi-sovereign, and corporate E.M. issuers.

The Wilshire U.S. REIT Index is a float-adjusted market capitalization-weighted index that measures U.S. publicly traded real estate investment trusts (REITs), excluding mortgage REITs, net-lease REITS, real estate finance companies, home builders, large landowners and sub-dividers, hybrid REITS, and companies that have more than 25% of their assets in direct mortgage investments.

The Wilshire ex U.S. Real Estate Investment Trust Index<sup>SM</sup> (Wilshire ex U.S. REIT) measures global publicly traded real estate investment trusts, less all U.S. securities. The Wilshire ex U.S. REIT is a subset of the Wilshire ex U.S. Real Estate Securities Index<sup>SM</sup> (Wilshire ex U.S. REIT).

The Wilshire Global REIT Index is a float-adjusted, market capitalization-weighted index that measures global publicly traded real estate investment trusts (REITs), excluding mortgage REITs, net-lease REITS, real estate finance companies, home builders, large landowners and sub-dividers, hybrid REITS, and companies that have more than 25% of their assets in direct mortgage investments.

Bloomberg Commodity Index (BCOM) is calculated on an excess return basis and reflects commodity futures price movements. The index rebalances annually weighted two-thirds by trading volume and one-third by world production, and weight-caps are applied at the commodity, sector, and group level for diversification. Roll period typically occurs from the sixth to the tenth business day based on the roll schedule.

The S&P GSCI Crude Oil Index is a sub-index of the S&P GSCI Commodity Index. The production-weighted index reflects the returns that are potentially available through an unleveraged investment in the West Texas Intermediate (WTI) crude oil futures contract.

The S&P GSCI (formerly the Goldman Sachs Commodity Index) serves as a benchmark for investment in the commodity markets and as a measure of commodity performance over time. The index was originally developed by Goldman Sachs. In 2007, ownership transferred to Standard & Poor's, which currently owns and publishes it. Futures of the S&P GSCI use a multiple of 250. The S&P GSCI contains as many commodities as possible, with rules excluding certain commodities to maintain liquidity and investability in the underlying futures markets. The index currently comprises 24 commodities from all commodity sectors.

The Wilshire Liquid Alternative Index<sup>SM</sup> measures the collective performance of the five Wilshire Liquid Alternative strategies that make up the Wilshire Liquid Alternative Universe. The Wilshire Liquid Alternative Index (WLIQA) is designed to provide a broad measure of the liquid alternative market by combining the performance of the Wilshire Liquid Alternative Equity Hedge Index<sup>SM</sup> (WLIQAEH), Wilshire Liquid Alternative Global Macro Index<sup>SM</sup> (WLIQAGM), Wilshire Liquid Alternative Relative Value Index<sup>SM</sup> (WLIQARV), Wilshire Liquid Alternative Multi-Strategy Index<sup>SM</sup> (WLIQAMS), and Wilshire Liquid Alternative Event Driven Index<sup>SM</sup> (WLIQAED).

The Wilshire U.S. Real Estate Securities Index<sup>5M</sup> (Wilshire US RESI) measures U.S. publicly-traded real estate securities. Designed to offer a market-based index that is more reflective of real estate held by pension funds, the Wilshire US RESI is comprised of publicly-traded real estate equity securities and unencumbered by limitations of other appraisal-based indexes. It can serve as a proxy for direct real estate investing by excluding securities whose value is not always tied to the value of the underlying real estate. Exclusions include: mortgage REITs, net-lease REITs, real estate finance companies, mortgage brokers and bankers, commercial and residential real estate brokers, home builders, large landowners and sub-dividers of unimproved land, hybrid REITs and timber REITs. The rationale for the exclusions is that factors other than real estate supply and demand, such as interest rates, can influence the market value of these companies.
