Stifel served as the exclusive financial advisor to Urban Farmer in its sale to Paine Schwartz Partners. The transaction represents the creation of a new sustainable food chain investment platform for Paine Schwartz Food Chain Fund V. Urban Farmer is a fully integrated manufacturer of better-for-you, plant-based specialty dough products. The Company serves a diverse, rapidly expanding blue-chip customer base, including the leading better-for-you pizza brands and major retailers across North America. Urban Farmer is a pioneer in the industry and the new investment platform established with Paine Schwartz will further contribute to the Company's focus on, and commitment to, ESG and sustainability. Stifel's Food & Beverage team became involved with Urban Farmer in early 2020.



Transaction Type: Senior Secured Credit Facility, and Unsecured Notes

The \$1.3 billion Senior Secured Credit Facility and \$335 million of Unsecured Notes were used to finance the acquisition of American Bath Group by Centerbridge Partners from Lone Star Funds, with management retaining a stake in the business. In addition to the debt financing, the \$1.85 billion acquisition was funded with an equity contribution from Centerbridge Partners of \$617 million. Pro forma net secured leverage was 4.6x, and total net total leverage was 5.9x. Both credit facilities priced at the lower end of the initial price talks, with a lower OID with respect to the Term Loan B. Stifel committed to a portion of the \$125 million Revolver, \$1.2 billion Term Loan B and \$335 million Unsecured Notes.



Stifel served as financial advisor to Ionis on its \$500 million acquisition of the remaining ~24% of Akcea common stock that it did not already own. The transaction drives efficiencies, enhances capabilities, and further strengthens Ionis' financial position and is a key step in the evolution of Ionis' business strategy. Ionis is the leader in RNA-targeted drug development, with an efficient, broadly applicable, drug discovery platform called antisense technology that can treat diseases where no other therapeutic approaches have proven effective. The Stifel team has been involved in numerous transactions with Ionis since 2012, including as sole advisor in Ionis' \$1.9 billion product collaboration in March 2018.

In December 2019 and January 2020, Stifel acted as sole placement agent for NetSTREIT's previous \$233 million 144A equity private placement. The 144A transaction helped facilitate the formation of the company, merge the initial portfolio, and internalize management. The 144A proceeds helped grow the portfolio with a composition and scale attractive to the public markets.

The \$205 million Senior Secured Credit Facilities were used to finance a management buyout and tender offer for WideOrbit's preferred and common equity. The transaction provided the Founder and CEO with majority ownership of the Company, as well as liquidity for minority investors who wished to exit. Stifel was able to successfully complete the transaction during extremely challenging market conditions in the Spring of 2020, and afforded the Founder the opportunity to purchase shares of the Company at an favorable valuation by running a broad syndication process.

- Upon closing, the combined company will be named Canoo Inc. and will be listed on the Nasdaq under the new ticker "CNOO"
