

Use of Non-GAAP Financial Measures




A History of Organic Growth & Acquisitions




A Diversified Growth Company




Pre-tax Margin¹

Revenue Contribution by Segment








National Presence








Equity Capital Markets Net Revenues ⁽³⁾⁽⁴⁾
