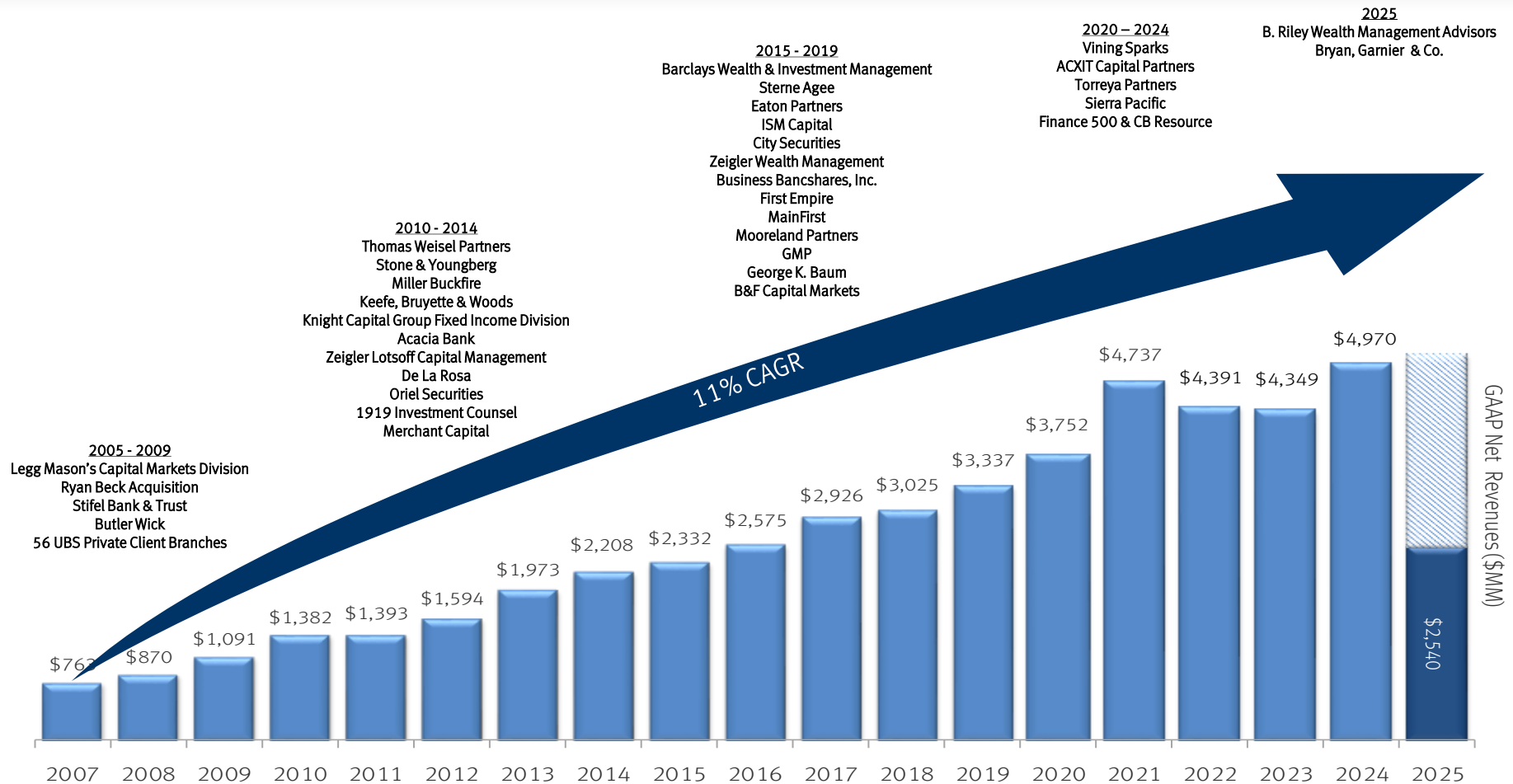

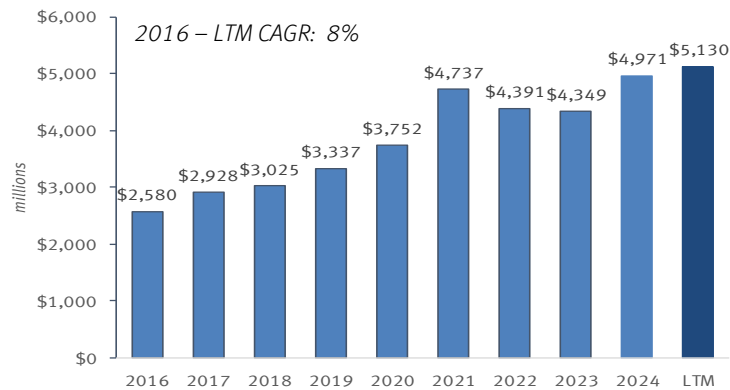

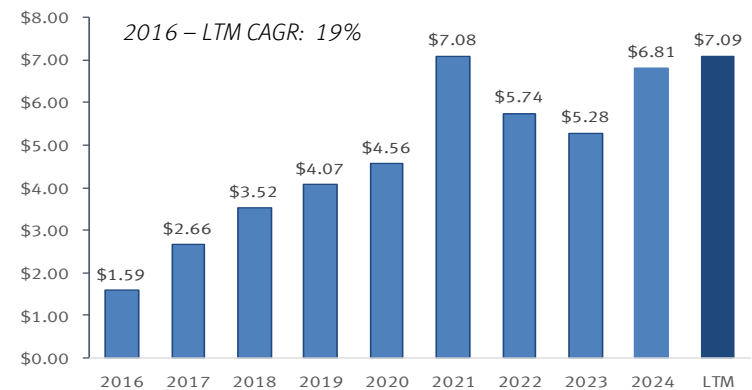
2025 full year GAAP net revenues based on annualized results as of 06/30/2025.

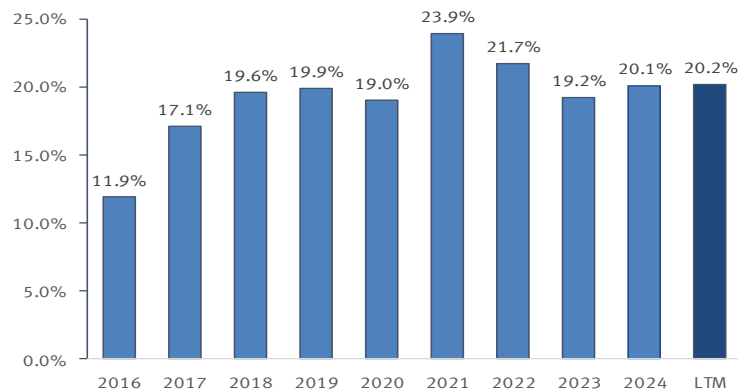
Net Revenue¹



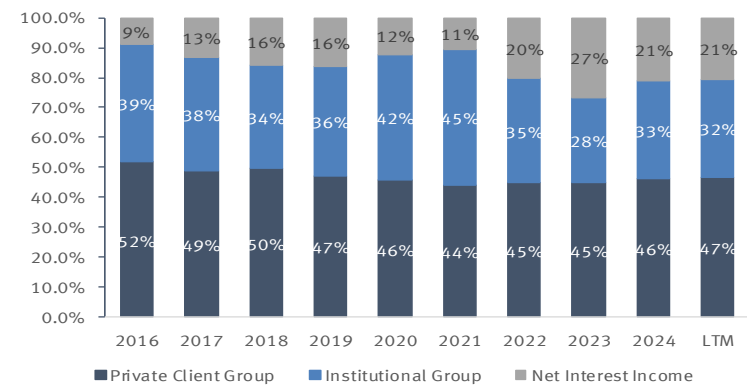
Earnings Per Share^{1,2,3}

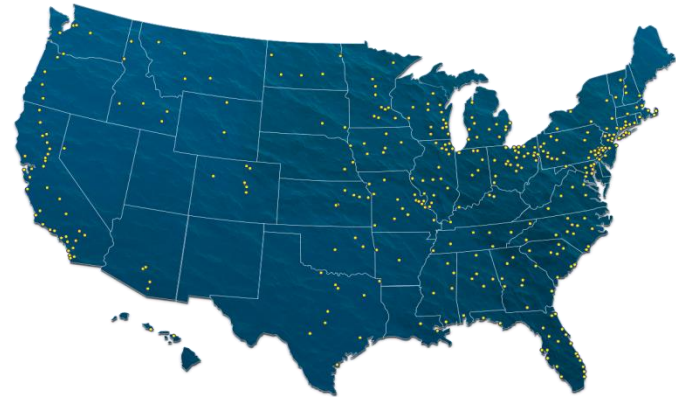

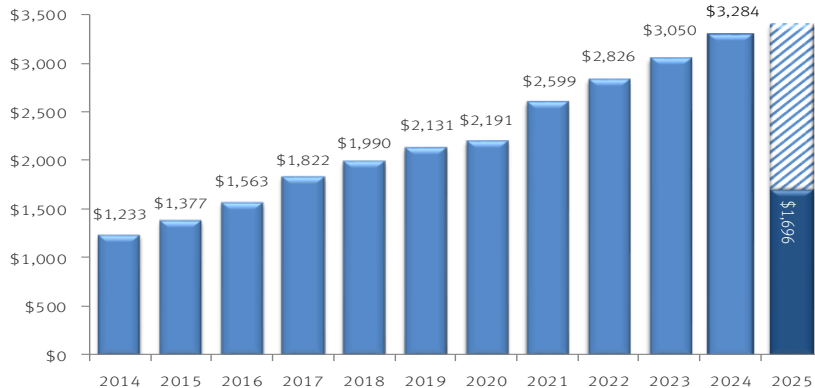

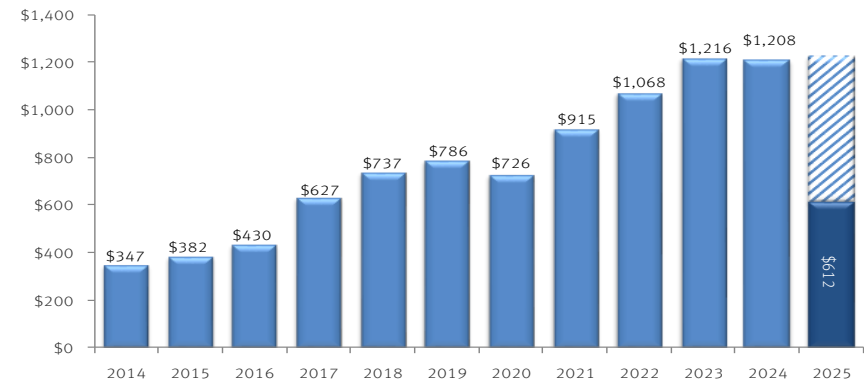
National Presence

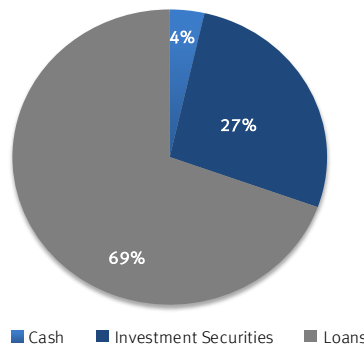

- Maintain high levels of liquidity

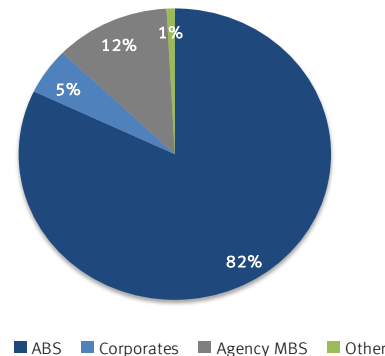

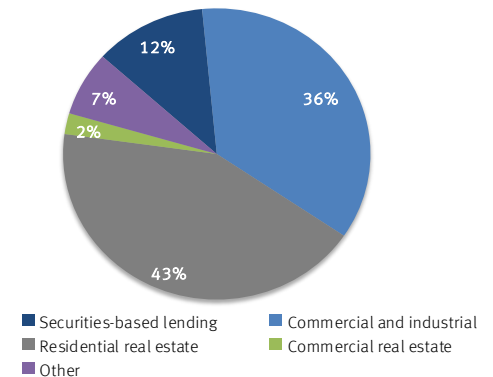
Interest Earning Assets

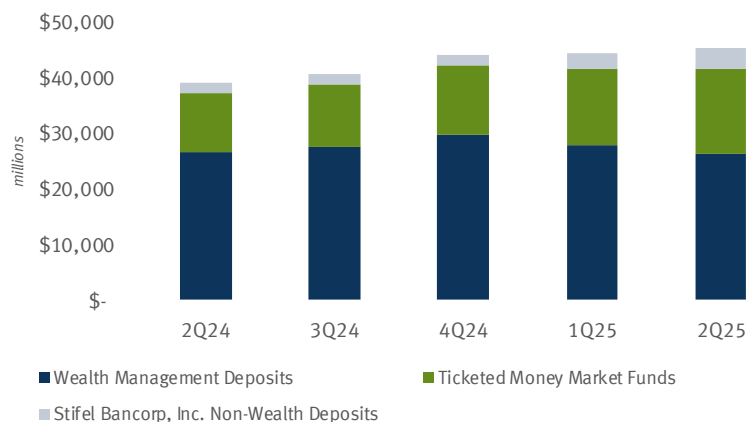

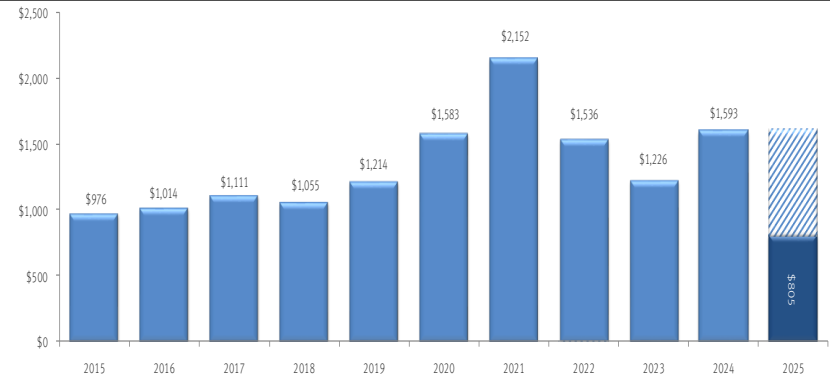

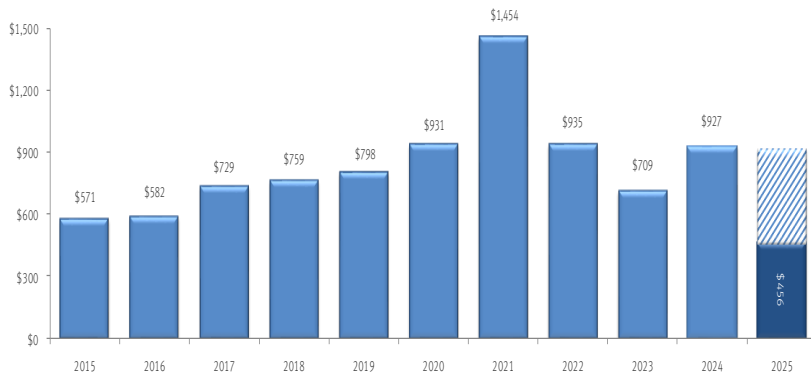

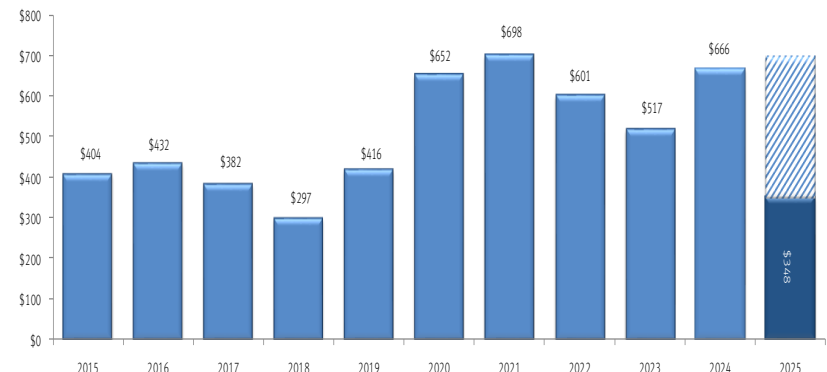
Net Revenues (\$MM)²
