MARKET PERSPECTIVES

U.S. ECONOMY

- The first estimate of fourth-quarter GDP was 2.9%, better than the 2.6% estimate, reflecting increases in inventories and higher consumer spending.
- The unemployment rate fell to 3.5% in December from 3.6% in November.
- Consumer sentiment rose to 64.9 in January from 59.7 in December.
- Inflation, as measured by the consumer price index, fell 0.1% in December (up 6.5% year over year (YoY)), in line with economists' expectations.

U.S. EQUITY MARKETS

- The S&P 500 started 2023 on a high note, ending January up 6.28% as investors grew more confident in the prospect of a "soft landing." Various inflation reports showed signs that price pressures continue to ease, potentially opening the door for the Federal Reserve (Fed) to pause its rate hikes. By the end of the month, 36% of the companies in the S&P 500 reported fourth-quarter earnings. Of those reporting, 70% reported earnings above estimates, below the five- and 10-year averages, 77% and 73%, respectively. The estimated blended (those reported and estimates of those yet to report) earnings decline is -4.6%. The energy sector is the largest positive contributor to YoY earnings, driven by elevated oil prices, averaging \$82.64 per barrel in the fourth quarter.
- The Russell 1000 Growth Index outperformed the Russell 1000 Value Index (8.33% versus 5.18%) in January. Large cap stocks, as represented by the Russell 1000 Index, underperformed small cap stocks, as represented by the Russell 2000 Index (6.70% versus 9.75%).

INTERNATIONAL ECONOMY AND MARKETS

- The MSCI EAFE Index, representing non-U.S. developed markets, rose 8.10%. Non-U.S. stocks outperformed the U.S., in part due to a weaker U.S. dollar, a milder winter in Europe, and China's loosening of COVID restrictions.
- Emerging markets (EM), represented by the MSCI Emerging Markets Index, rose 7.9%, driven largely by China. The MSCI China Index rose 12.26%.

February 2023

FIXED INCOME

- Yields fell during the month, but the Treasury curve remained inverted. The yield on the 10-year U.S. Treasury ended the month at 3.51% versus 3.87% in December. The 2-10 spread (the difference between the 10-year Treasury yield and 2-year Treasury yield) remains inverted at -69 basis points (bps). The 2-year Treasury yield fell 22 bps to 4.20%.
- The Federal Open Market Committee (FOMC) December meeting minutes showed members did not anticipate any rate cuts in 2023 and that the Fed would be open to a higher "terminal" rate if elevated inflation persisted. Fed officials said there are some possibilities for a soft landing to still occur, noting household cash reserves are still elevated.
- At the end of the month, traders of fed funds futures were pricing in a 99.7% probability of a 25-bps hike at its next meeting¹, and a 79.8% probability for a total of 50 bps in hikes for all of 2023. This compares to 425 bps of hikes for all of 2022.
- Both investment-grade corporate spreads and high-yield corporate spreads slightly tightened during the month. The Bloomberg U.S. Aggregate Index rose 3.08%, and the Bloomberg U.S. Corporate High Yield Index rose 4.18%.

CURRENCY/COMMODITIES/REAL ESTATE

- West Texas Intermediate (WTI) fell 2.55% to \$78.87/barrel in January.
- Gold prices rose in January, closing at \$1,928.36/oz., up 5.72% from \$1,824.02/oz. in December.
- The U.S. dollar fell in January against a basket of currencies, closing the month at 102.09 versus 103.52 in December.
- Domestic real estate finished the month higher, as the Wilshire U.S. Real Estate Securities Index rose 11.33% in January.

¹The Fed hiked interest rates 25 bps at its February meeting, bringing the target range to 4.5%-4.75%.

Index Descriptions

The Russell 3000 Index measures the performance of the 3,000 largest U.S. companies based on total market capitalization, which represents approximately 98% of the investable U.S. equity market. The Standard & Poor's 500 Index is a capitalization-weighted index that is generally considered representative of the U.S. large capitalization market.

The Standard & Poor's/TSX Composite Index is the benchmark Canadian index, representing roughly 70% of the total market capitalization on the Toronto Stock Exchange with about 250 companies included in it.

The NASDAQ Composite Index is a capitalization-weighted index that is comprised of all stocks listed on the National Association of Securities Dealers Automated Quotation System stock market, which includes both domestic and foreign companies.

The Russell 1000 Index measures the performance of the 1,000 largest companies in the Russell 3000 Index, which measures the performance of the 3,000 largest U.S. companies based on total market capitalization. The average market capitalization is approximately \$11 billion, and the median market capitalization is approximately \$3.5 billion.

The Russell 1000 Growth Index measures the performance of those Russell 1000 index companies with higher price-to-book ratios and higher forecasted growth values.

The Russell 1000 Value Index measures the performance of those Russell 1000 index companies with lower price-to-book ratios and lower forecasted growth values.

The Russell 2000 Index measures the performance of the 2,000 smallest companies in the broader Russell 3000 Index, which measures the performance of the 3,000 largest U.S. companies based on total market capitalization. The Russell 2000 Growth Index measures the performance of those Russell 2000 index companies with higher price-to-book ratios and higher forecasted growth values.

The Russell Microcap Index is a capitalization-weighted index of 2,000 small cap and micro cap stocks, including the smallest 1,000 companies in the Russell 2000 plus 1,000 smaller U.S. based listed stocks. Over-the-counter stocks and pink sheet securities are excluded.

The Bloomberg U.S. Treasury U.S. TIPS index includes all publicly issued, U.S. Treasury inflation-protected securities that have at least one year remaining to maturity, are rated investment grade, and have \$250 million or more of outstanding face value.

The Bloomberg U.S. Municipal Index covers the U.S. dollar-denominated, long-term, tax-exempt bond market. The index has four main sectors: state and local general obligation bonds, revenue bonds, insured bonds, and prerefunded bonds.

The Bloomberg U.S. Credit Index measures the investment-grade, U.S. dollar-denominated, fixed-rate, taxable corporate and government-related bond markets. The Wilshire U.S. REIT Index is a float-adjusted market capitalization-weighted index that measures U.S. publicly traded real estate investment trusts (REITs), excluding mortgage REITs, net-lease REITS, real estate finance companies, home builders, large landowners and sub-dividers, hybrid REITS, and companies that have more than 25% of their assets in direct mortgage investments.

The Wilshire ex U.S. Real Estate Investment Trust IndexSM (Wilshire ex U.S. REIT) measures global publicly traded real estate investment trusts, less all U.S. securities. The Wilshire ex U.S. REIT is a subset of the Wilshire ex U.S. Real Estate Securities IndexSM (Wilshire ex U.S. RESI).

The Wilshire Global REIT Index is a float-adjusted, market capitalization-weighted index that measures global publicly traded real estate investment trusts (REITs), excluding mortgage REITs, net-lease REITS, real estate finance companies, home builders, large landowners and sub-dividers, hybrid REITS, and companies that have more than 25% of their assets in direct mortgage investments.

Bloomberg Commodity Index (BCOM) is calculated on an excess return basis and reflects commodity futures price movements. The index rebalances annually weighted two-thirds by trading volume and one-third by world production, and weight-caps are applied at the commodity, sector, and group level for diversification. Roll period typically occurs from the sixth to the tenth business day based on the roll schedule.

The S&P GSCI Crude Oil Index is a sub-index of the S&P GSCI Commodity Index. The production-weighted index reflects the returns that are potentially available through an unleveraged investment in the West Texas Intermediate (WTI) crude oil futures contract.

The S&P GSCI (formerly the Goldman Sachs Commodity Index) serves as a benchmark for investment in the commodity markets and as a measure of commodity performance over time. The index was originally developed by Goldman Sachs. In 2007, ownership transferred to Standard & Poor's, which currently owns and publishes it. Futures of the S&P GSCI use a multiple of 250. The S&P GSCI contains as many commodities as possible, with rules excluding certain commodities to maintain liquidity and investability in the underlying futures markets. The index currently comprises 24 commodities from all commodity sectors.

The Wilshire Liquid Alternative IndexSM measures the collective performance of the five Wilshire Liquid Alternative strategies that make up the Wilshire Liquid Alternative Universe. The Wilshire Liquid Alternative Index (WLIQA) is designed to provide a broad measure of the liquid alternative market by combining the performance of the Wilshire Liquid Alternative Equity Hedge IndexSM (WLIQAEH), Wilshire Liquid Alternative Global Macro IndexSM (WLIQAGM), Wilshire Liquid Alternative Relative Value IndexSM (WLIQARV), Wilshire Liquid Alternative Multi-Strategy IndexSM (WLIQAMS), and Wilshire Liquid Alternative Event Driven IndexSM (WLIQAED).

The Wilshire U.S. Real Estate Securities Index^{5M} (Wilshire US RESI) measures U.S. publicly-traded real estate securities. Designed to offer a market-based index that is more reflective of real estate held by pension funds, the Wilshire US RESI is comprised of publicly-traded real estate equity securities and unencumbered by limitations of other appraisal-based indexes. It can serve as a proxy for direct real estate investing by excluding securities whose value is not always fied to the value of the underlying real estate. Exclusions include: mortgage REITs, net-lease REITs, real estate finance companies, mortgage brokers and bankers. commercial and residential real estate brokers, home builders, large landowners and sub-dividers of unimproved land, hybrid REITs and timber REITs. The rationale for the exclusions is that factors other than real estate supply and demand, such as interest rates, can influence the market value of these companies.
