WHAT TO KNOW:

U.S. Equities Rose Last Week

The S&P 500 rose for a second consecutive week. Notably, the S&P 500 has risen for the past nine trading sessions and has fully recovered from the reciprocal tariff announcements on April 2. Earnings from the four names in the Magnificent Seven** helped boost sentiment for AI-exposed stocks, overshadowing mixed economic data. The latest <u>Sight|Lines</u> examines the first 100 days of the second Trump administration, reviewing its actions, increased uncertainty, and some economic and market data seen so far.

Negative First Quarter (Q1) U.S. GDP Print; April Jobs Report Mixed

The first estimate for Q1 2025 GDP growth came in at -0.3%, reflecting a large increase in imports as companies stockpiled ahead of tariffs as well as a decline in government spending. Consumer spending slowed to 1.8%, down from 4.0% the prior quarter, and prices rose sharply, suggesting sticky inflation. Meanwhile, the jobs report showed the U.S. added 177,000 jobs in April, beating estimates. Nonfarm payrolls, however, were revised 58,000 lower for the past two months. The unemployment rate remained at 4.2%. Considering persistent inflation, slowing economic growth, and policy uncertainty, market pricing is implying a base case of three rate cuts from the Federal Reserve over 2025.


M7 Supporting S&P 500 Earnings Growth; Increased Uncertainty for Q2 on Tariffs Over 70% of S&P 500 companies have reported their earnings, including major players like Amazon, Apple, Meta, and Microsoft last week. Their strong earnings results led to a significant upward revision in Q1 earnings growth for the S&P 500. The overall growth rate for Q1 is now estimated to be 12.8%, up from 6.8% at the end of March. Yet guidance for Q2 from Apple and Amazon disappointed as tariffs weighed on their outlook. Consequently, analysts have lowered the full-year earnings per share estimates, with the bottom-up estimate declining from 12.6% at the start of the year to 9.4%. The energy sector is the only sector forecasted to see earnings decline this year.

S&P 500 Equal Weight Index is the equal-weight version of the widely regarded Standard & Poor's 500 Index, which is generally considered representative of the U.S. large capitalization market. The index has the same constituents as the capitalization-weighted S&P 500, but each company in the index is allocated a fixed weight of 0.20% at each quarterly rebalancing.

S&P GICS Index is a benchmark for investment in the commodity markets and as a measure of commodity performance over time. The index was originally developed by Goldman Sachs. In 2007, ownership transferred to Standard & Poor's, which currently owns and publishes it. Futures of the S&P GSCI use a multiple of 250. The S&P GSCI contains as many commodities as possible, with rules excluding certain commodities to maintain liquidity and investability in the underlying futures markets. The index currently comprises 24 commodities from all commodity sectors.

This volatility is meant to be forward looking, is calculated from both calls and puts, and is a widely used measure of market risk, often referred to as the "investor fear gauge."

ISM Non-Manufacturing Index is an index based on surveys of more than 400 nonmanufacturing firms' purchasing and supply executives, within 60 sectors across the nation, by the Institute of Supply Management (ISM).

NFIB Small Business Optimism Index is compiled from a survey that is conducted each month by the National Federation of Independent Business (NFIB) of its members. The index is a composite of ten seasonally adjusted components based on questions on the following: plans to increase employment, plans to make capital outlays, plans to increase inventories, expect economy to improve, expect real sales higher, current inventory, current job openings, expected credit conditions, now a good time to expand, and earnings trend.
